<b>MIAMI-DADE COUNTY</b>	<p>All persons shall be required to wear a mask or other facial covering when in public.</p> <p>Masks and other facial coverings shall <u>not</u> be required:</p> <ul style="list-style-type: none"> <li>- at or inside a private residence;</li> <li>- inside a private automobile;</li> <li>- at or inside any religious institution, without limitation;</li> <li>- inside a hotel, motel, or commercial lodging establishment guest rooms, or inside any apartment;</li> <li>- of children under the age of two years;</li> <li>- of persons who cannot wear a mask or facial covering due to an existing medical condition;</li> <li>- of an individual who is hearing impaired or an individual who is communicating with an individual who is hearing impaired;</li> <li>- where federal or state safety or health regulations prohibit the wearing of facial coverings;</li> <li>- of persons actively engaged in strenuous physical activity, either inside or outdoors;</li> <li>- of persons swimming or engaged in other activities which may cause the facial covering to become wet;</li> <li>- while persons are actively eating, drinking, or smoking; and</li> <li>- while a person is receiving services which require access to that person's nose or mouth</li> </ul> <p><b>On July 16, 2020, Miami-Dade County Board of County Commissioners voted to approve <a href="#">Substitute Special Item No. 7</a>. <p><b>CITY OF AVENTURA</b></p>	<p>Same as MDC <a href="#">Emergency Order 20-20</a>.</p> <p>In addition, persons entering or walking through interior or exterior "Common Areas" of commercial buildings, residential condominium buildings, and residential cooperative buildings are required to wear facial coverings.</p> <ul style="list-style-type: none"> <li>- "Common Areas" include lobby/reception areas, hallways, elevators, mailrooms, clubhouse/meeting rooms, and stairwells.</li> </ul> <p>For all persons attending religious services, inside or outside, it is mandatory to wear a facial covering, unless social distancing can be maintained throughout services.</p>	<p><a href="#">Order #14</a></p> <p><a href="#">Order #14 Revised</a></p>	<p><a href="#">Here</a></p>

### BROWARD COUNTY

<p>Facial coverings are required in all public spaces where social distancing cannot be maintained.</p> <p>The following persons are required to wear facial coverings regardless of whether social distancing can be maintained:</p> <ul style="list-style-type: none"> <li>- All persons in an establishment, business, or amenity operating in Broward County;</li> <li>- All persons while working in an establishment permitted to operate under any Executive Order of the Governor or any Broward County Emergency Order;</li> <li>- Members of the public when obtaining any good or service or otherwise visiting any establishment, including entering, exiting, and otherwise moving around within the establishment</li> <li>- All workers of any establishment while involved in the preparation, handling, or service of food;</li> <li>- All persons while in any common area of a multi-family housing development or residential facility, including without limitation the reception area, hallways, and elevators; and</li> <li>- To the extent required by any Executive Order of the Governor or any Broward County Emergency Order</li> </ul>	<a href="#">Emergency Order 20-20</a>	<a href="#">Here</a>



## REGULATIONS REGARDING FACE COVERINGS

<p>Facial coverings are <u>not</u> required for the following individuals:</p> <ul style="list-style-type: none"> <li>- Children under the age of two, and any child, regardless of age, while under the custody of a licensed childcare facility, including daycare centers;</li> <li>- Persons receiving goods or services from a business or establishment for the shortest practical period of time during which the receipt of such goods or services precludes the wearing of a facial covering (such as eating, drinking, or receiving a facial grooming);</li> <li>- A person with a disability or medical condition that prevents that person from wearing a facial covering</li> <li>- Public health and safety, fire, and other life safety personnel, as their personal protective equipment requirements will be governed by their respective agencies; and</li> <li>- While actively engaging in strenuous physical activity or exercise that renders the wearing of a facial covering unsafe.</li> </ul>

<ul style="list-style-type: none"> <li>- Children under two years of age and any while under the custody of a licensed childcare facility, including daycare centers;</li> <li>- Persons prohibited from wearing facial coverings by Federal or State safety or health regulations;</li> <li>- Public safety, fire, or other life safety personnel that have personal protective equipment requirements governed by their respective agencies;</li> <li>- Individuals while actively engaged in exercise and maintain social distancing in accordance with CDC guidelines;</li> <li>- Persons receiving goods or services from a business or establishment for the shortest period of time during which the receipt of such good or services necessarily precludes the wearing of a facial covering such as, but not limited to, consuming food or beverage or receiving a facial grooming or treatment;</li> <li>- Persons who have a medical condition that makes the wearing of a facial covering unsafe such as, but not limited to, asthma, COPD, other conditions that reduce breathing or lung capacity;</li> <li>- Persons for whom wearing a facial covering conflicts with their religious beliefs or practices; and</li> <li>- Facial coverings may be removed temporarily assisting persons who are hearing impaired or who rely on reading lips in order to communicate</li> </ul> <p>All restaurants and food service establishments shall post signage as follows:</p> <ul style="list-style-type: none"> <li>- <a href="#">Restaurant Face Mask Poster</a></li> <li>- <a href="#">Restaurant Face Mask Poster - Spanish</a></li> <li>- <a href="#">Restaurant Face Mask Poster - Creole</a></li> <li>- <a href="#">Retail Face Mask Poster</a></li> <li>- <a href="#">Retail Face Mask Poster - Creole</a></li> </ul>

<p>Face coverings are required at:</p> <ul style="list-style-type: none"> <li>- Indoor and outdoor public places, businesses and establishments;</li> <li>- Restaurants and food service establishments; and</li> <li>- County and municipal government facilities</li> </ul> <p>Face coverings are not required for the following:</p> <ul style="list-style-type: none"> <li>- Children under six years of age while under the custody of a licensed childcare facility, including schools, summer camps, and daycare centers</li> <li>- Individuals prohibited from wearing face coverings by Federal or State safety or health regulations</li> <li>- Public safety, fire, or other life safety personnel that have personal protective equipment requirements governed by their respective agencies</li> <li>- Persons actively engaged in exercise and who are social distancing in accordance with CDC guidelines</li> <li>- Persons receiving goods and services from a business or establishment for the shortest practical period of time during which the receipt of such goods or services necessarily precludes the wearing of a face covering such as, but not limited to, consuming food or beverage or receiving dental services, facial grooming, or treatments</li> <li>- Persons who have a medical condition or disability that makes the wearing of a face covering unsafe</li> <li>- Persons may temporarily remove face coverings while assisting persons who are hearing impaired or who rely on reading lips in order to communicate</li> <li>- Persons in a private room of a lodging establishments, such as a hotel, motel, or vacation rental; however, face coverings must be worn in common areas</li> <li>- Persons engaged in outdoor work or recreation with appropriate social distancing pursuant to CDC guidelines in place and being practices</li> </ul>	<p><a href="#">Emergency Ordinance No. 1136</a></p>	<p><a href="#">Here</a></p>
