

# ACCESS AGREEMENT FOR MIAMI ASSOCIATION OF REALTORS® ONLINE JOB BOARD

- 3. Those using the Job Board for the purpose of filling job openings are prohibited from posting any incomplete, false, or inaccurate employment history or other biographical information.
