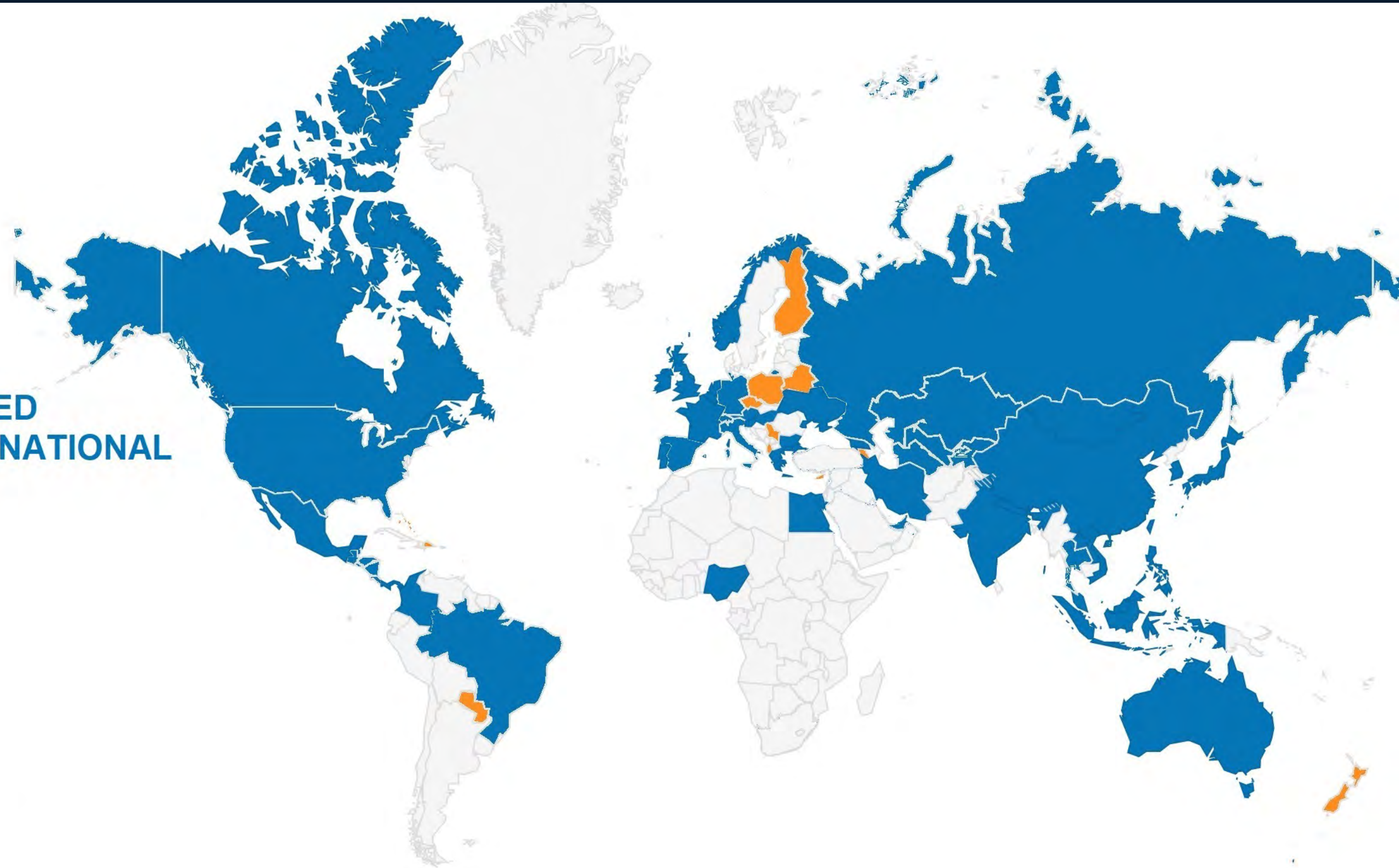
## Global Map

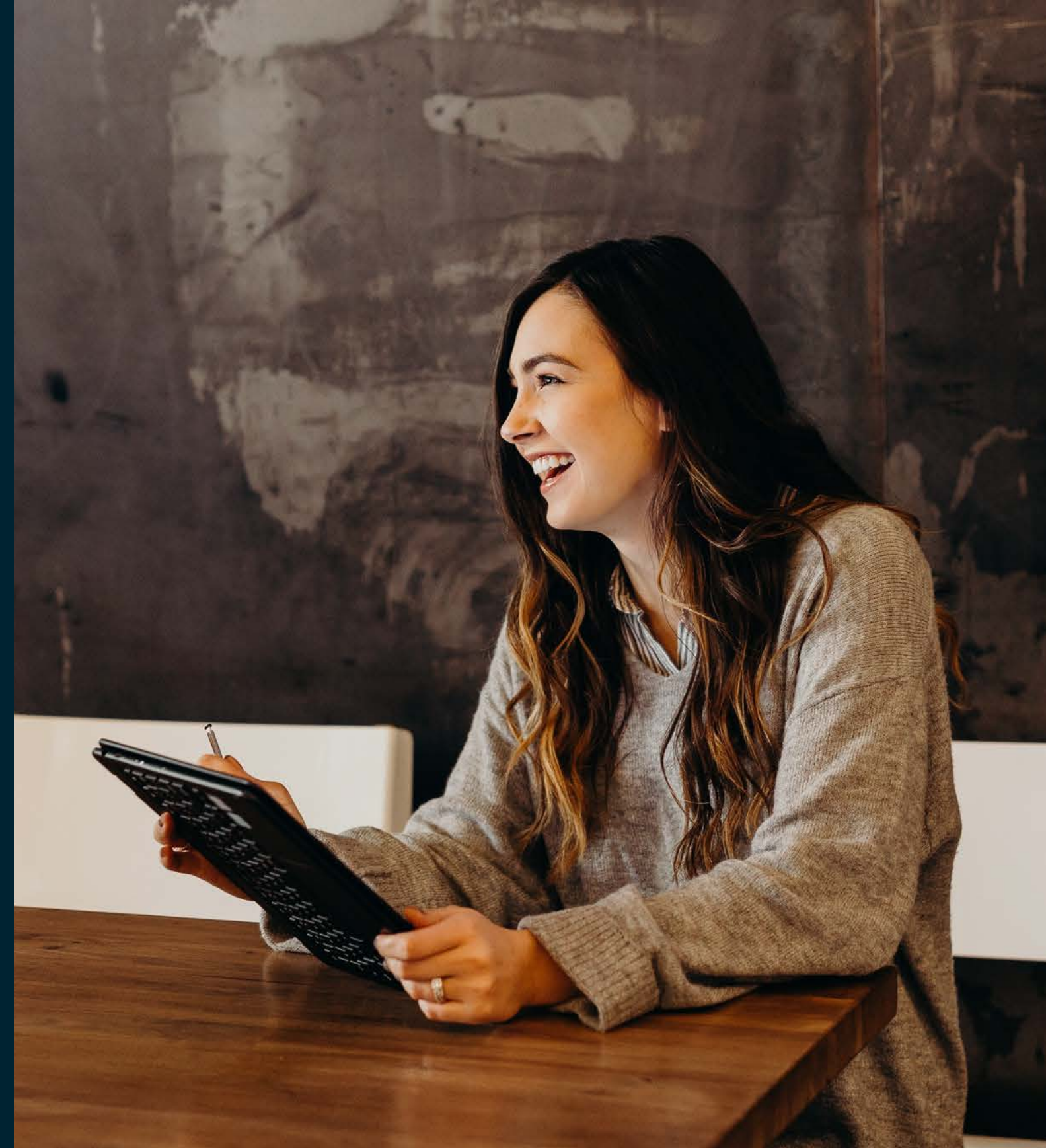

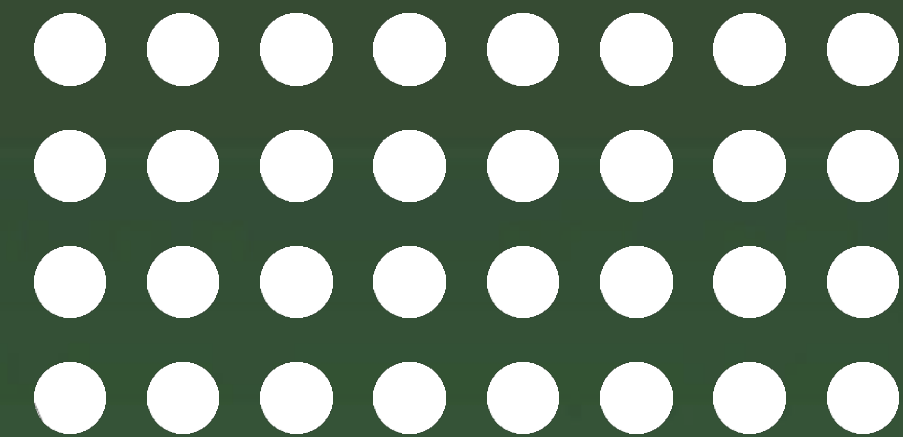
