

## Broward County Local Residential Market Metrics - Q4 2023 Reference Map - Countywide Municipalities and Census-Designated Places\*







## Broward County Local Residential Market Metrics - Q4 2023 Reference Map - East Central Broward Municipalities and Census-Designated Places\*






