

## Palm Beach County Local Residential Market Metrics - 2024 Reference Map - Northeastern Palm Beach County Municipalities and Census-Designated Places\*







## Palm Beach County Local Residential Market Metrics - 2024 Reference Map - East Central Palm Beach County Municipalities and Census-Designated Places\*



## Palm Beach County Local Residential Market Metrics - 2024 Reference Map - Southeastern Palm Beach County Municipalities and Census-Designated Places\*






