

### Broward County Local Residential Market Metrics - Q3 2025 Reference Map - Countywide Municipalities and Census-Designated Places\*







# Broward County Local Residential Market Metrics - Q3 2025 Reference Map - East Central Broward Municipalities and Census-Designated Places\*






